## CyberTrax2<sup>™</sup> Release Notes

#### 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

#### 2. About This Release

CyberTrax2 Release 2.34.15 includes some changes to ASN 2.0 for re-approving the shipments on new tab, adding a filter for pending air approval shipment, e-mail notification to air approvers for shipments that have been pre-approved for air, hiding piece price and total value fields from international portal, controlling expedite feature to require user to enter comment, enabling report as well as flashlight to show expedited shipments as output report. Enabling "Actual Departure to Actual Delivery" Flashlight. Improving and adding on client watch list to show all estimated dates as well as any actions changed since last viewed. Changing and improving schedule report to integrate list of reports to be condition on Main report, adding more output fields, output layout options, etc. Adding "Clone" feature to schedule report component to allow users to create a new report by cloning to save time. Adding Email, dashboard for pre-approved for Air, pending for final air approval. Adding a checkbox to enable/disable to send email only if there is at least one shipment on the report. Bug fixing on ASN 2.0, Flashlight, and Main report.

#### 3. Projects

#### 3.1 ASN 2.0

• Mantis IDs: 0004524: Control per portal: require comment before the Expedited Request is processed **Description of Change:** Ability to enable/disable the comment field to be a mandatory field for expedited feature.

• Mantis IDs: 0004535: [ASN 2.0] Pending Air Approval Filter (filter should also display "count") Description of Change: Adding a filter for shipments that are pending for air approval. This filter is a button with counter (x) for number of pending shipments for air approval. This allows planner to filter the pre-approved shipments for air and execute quickly. User can click on this button when it is more than "0" shipments.

• Mantis IDs: 0004537: Allow Planners to re-approve with mode changes from Air to other MOTs for ASN shipments on NEW Tab

**Description of Change:** Allowing planners to re-approve with ability to change mode from Air to other mode of transportation for any shipments on new tab. This was a gap when shipment was pre-approved to Air and it became no longer editable. Only way was to wait for the air approver to approve and change MOT if MOT needed to be changed. Now it is no longer a gap in the system and allows planners to change MOT as long as the shipments are still on new tab.

• Mantis IDs: 0004538: Email notification to air approvers when shipments have been Pre-Approved for AIR, pending Final Air Approval

**Description of Change:** Adding an email notification to air approvers for specific PO Issued by when shipments have been pre-approved for Air and pending for final air approval.



• Mantis IDs: 0004541: [ASN 2.0] Hide Piece price, total value fields and remove the validation Description of Change: Hiding and removing the validation for mandatory piece price field and total value on EA International portal.

#### 3.2 Flashlight

- Mantis IDs: 0004501: Volume KPI (same as CT count, for example > count of expedites) Description of Change: Adding a new KPI to Volume KPI for expedited shipments count.
- Mantis IDs: 0004522: [LeadTime]: Act Departure to Act Delivery [All Modes] Act Pick up date [Truck] to Act Delivery date

Description of Change: Adding a new KPI to LeadTime for Actual Departure to Actual Delivery.

#### 3.3 Report

• Mantis IDs: 0004483: Integrate step 1 reports to Main report

**Description of Change:** Integrating group 1 reports to main report condition: New (Daily), Incomplete, Impending Arrival, Impending Departure, Impending Delivery, Impending Collection, Impending Port of Discharge, Impending Port of Loading, Impending Cargo Due, Impending with Past Due Departure, Impending with Past Due Arrival, Impending with Past Due Cargo Due, all conditions for Impending with X days, Previous Collection and Previous Delivery.

• Mantis IDs: 0004502: Dashboard - Main report Level2 for Client application Description of Change: Enabling level 2 for client dashboard reports on client application.

• Mantis IDs: 0004504: Expedited shipment should be available on report output and filter for Main Description of Change: Adding reason code and expedite comment to report output and reason code to filter on main report.

• Mantis IDs: 0004506: *Re-label for output field on main report* Description of Change: Changing the label from "Containers Number" to "Container #."

• Mantis IDs: 0004519: Add "Clone" feature for the schedule report Description of Change: Adding "Clone" feature on the schedule report to allow users to easily copy the report to create new with ability to modify the setting of the report.

• Mantis IDs: 0004534: Daily Report for "New ASNs" ---> Send only if there is at least 1 ASN shipment Description of Change: Adding a check box on the schedule report to send email only if there is at least 1 shipment on the report; meaning that if there is "0" shipment, do not send email notification for that day.



• Mantis IDs: 0004536: [Report] Email/Dashboard --> Pre-Approved for AIR, pending Final Air Approval Description of Change: Adding a new condition filter to ASN report for pre-approved for air, pending for final air approval dashboard report with ability to send email notification when there is at least 1 ASN shipment.

• Mantis IDs: 0004559: [Main report] Add more report output

**Description of Change:** Adding "Customs Status", "Customs Date", "FDA Status", "FDA Date" to report output fields. These fields are available for Air and Ocean mode of transportations.

#### 3.4 Client Application

• Mantis IDs: 0004554: [Watchlist] Expand notification to all Est date as well as any actions have changed since the last view

**Description of Change:** Expanding notification to all estimated dates as well as displaying list of actions that have been changed since the last view by specific user.

#### 4. Bugs Fixes and Changes

#### 4.1 ASN 2.0

• Mantis IDs: 0004530: Origin Country not populated from approved ASN Description of Change: Fixing bug on origin and destination country that was not auto populated from approved ASN shipments.

• Mantis IDs: 0004557: [ASN 20 ph3] bug: partial approval of undefined ASN generates exception Description of Change: Fixing bug on exception error that occurred when there was a partial approval of undefined ASN shipment.

#### 4.2 Flashlight

• **Mantis IDs:** 0004568: Bug: No data on the top graph once clicking on the bottom graph

**Description of Change:** Fixing bug on the top graph to show data correctly. This bug occurred upon clicking on the bottom right chart on Carrier tab. It was shown incorrectly as it showed no data on the top graph.



#### 4.3 Report

• Mantis IDs: 0004515: (\*Main Report) bug: For scheduled report, Level2 shows incorrect counters(by Client company filter)

Description of Change: Fixing bug on level 2 counters on Client company filter to show it correctly.

• Mantis IDs: 0004532: (*Reps:CT Record*) CT#477888 presented in the report in two different tabs **Description of Change:** Fixing bug on a specific CT to present correctly.
