## CyberTrax2<sup>™</sup> Release Notes

#### 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

#### 2. About This Release

CyberTrax2 Release 2.42.0 includes an additional weight dims validation for "totes". Implement "ASN Status" as filter and output on main report. Implement additional validation for transmitting a booking request to Evergreen steamshipline to require a vessel name or voyage. Implement charge codes as an output for main report. As well as bug fixes on rounding issue on P/L and credit notes to display the same value.

#### 3. Projects

#### 3.1 ASN

- Mantis IDs: 0004992: [ASN 2.0] Weight Dims validations for "totes". A warning message should show validation text displayed in kg or lb depends on what unit user selects to use. Provide 2 decimal rounding in warning messages and admin section and rounding a minimum value to higher and a maximum value to lower values. Update a warning message to show "The total Gross Weight must be between XX kg and XXX kg". Warning message should automatically show range of total GW calculated from entered items.
- Mantis IDs: 0004964: [Main report] Add "ASN Status" as filter and output

  Description of Change: Adding ASN status as a multi-selected filter to display ASN status output in one column.

#### 3.2 EDI to Cargosmart

Mantis IDs: 0004995: EDI to CargoSmart - Mandatory segment V1 in BR (EDI 300) required by Evergreen
 Description of Change: Implement an additional validation for Evergreen steamshipline to require a vessel name under segment V102 in order to transmit a booking request via EDI to Cargosmart

#### 3.3 Report

Mantis IDs: 0004978: Report for Billing code
 Description of Change: Adding "Sale Invoices Charge Code Amount" as an output field to list of charge codes

#### 4.1 Accounting

Mantis IDs: 0004984: (P/L Tab) P&L displays different amount than actual credit notes. A rounding issue.
 Description of Change: Fix a rounding issue on P&L to display the same amount as actual credit notes when the credit note amount is not issued in USD.



• Mantis IDs: 0004991: (Acc: SI&II) Bug: Wrong amount for credit note on the P&L tab. Description of Change: Fix the bug on incorrect amount for credit note on the P/L tab.
