CyberTrax2[™] Release Notes

1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.25.0 includes a major enhancement to the Client application, minor supporting change to the Internal application (user admin), and three urgent GM Split change requests. This release contains the first production deliverable for the DR/KPI Project.

CyberTrax2 Release 2.25.1 includes a hotfix to resolve Client Application display issues on low resolution settings.

3. Projects

3.1 DR/KPI

Mantis IDs: 0003595: [DR/KPI] DR3 Phase 1A.1: EA DOM Portal only, Main View only

Description of Change: Key Performance Indicators (KPIs) are valuable metrics that clients and Jaguar Freight Services (JFS) can utilize to improve their supply chain management operations. These metrics report on cost performance, cycle time performance, load utilization performance, etc.

This release includes the Main View of a new Cost-per-Unit Multi-panel layout. This feature is currently limited to:

- EA DOM Client Company
- Mode of Transportation Truck Domestic

4. Bugs Fixes and Changes

4.1 GM Split

Mantis ID: 3674 SOW 20 Changes to Consolidated Inv: rename, replace columns, etc

Description of Change: Cosmetic changes to GMS Consolidated Invoice. Add GRP# column and report invoice amount at GRP level instead of CT level.

Mantis ID: 3675 Discrepancy between P/L, Consol pdf and GMS Log

Description of Change: Modified individual GMS invoices (located in P/L tab) to generate one invoice per group rather than one invoice per CT. Modified PDF report to be consistent with numbers presented on P/L tab.

Mantis ID: 3678 SOW 21 Changes to GMS Log: add Rev Rec date; create one line per invoice

Description of Change: Add Revenue Recognition date to GMS Log and create separate line for each consolidated invoice.



4.2 Client App

Mantis ID: 0003689: Client App Main View Issues for Client, Shipper & Planner Roles

Description of Change: Updated Client App to prevent overlapping/hidden fields on lower resolution display settings. Updated main CSS file to behave similarly to previous version.

5. Known Bugs and Limitations

5.1 DR/KPI

Mantis IDs: 0003595: [DR/KPI] DR3 Phase 1A.1: EA DOM Portal only, Main View only

Description of Bug/Limitation: There are data issues in CyberTrax2 regarding load plans and weights. This causes some unusually high cost/pound rates in the Cost based KPIs. Some of the lanes may report over \$1,000/lb due to this data. We do not plan on modifying our DR/KPI modules to circumvent this data issue - we will need to resolve the discrepancies in CT2 production database for these charts to report properly.
