1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.34.1 includes some changes of ASN 2.0 portals per mode of transportation to enable/disable multi commodity line items per shipment or single commodity line per shipment. This is to have the same functionality of ASN 1 to ASN 2. Allow planners to approve multi-records at once on ASN 2 to have the same functionality of ASN 1 planners. Lastly for the change of incomplete purchase invoice for accounting component of super account and management to have ability to view global or individual info by selecting an office filter.

3. Projects

3.1 Accounting

- **Mantis IDs:** 0004438: *Add filter for offices with ability to select all offices for Incompleted purchase Invoices for Super Acc*

Description of Change: Add an Office filter to the Incomplete Purchase Invoices Report (in the accounting section), to enable Super Accounting and Management users to access global information.

3.2 ASN 2.0

- **Mantis IDs:** 0004434: *Change ASN 2: ability to enable/disable to create 1 line item per shipment per MOT per Portal*

Description of Change: Add ability to enable/disable ability for shipper to create 1 line item per shipment per MOT per Portal upon “save” during shipment creation.

- **Mantis IDs:** 0004435: *Change ASN 2: ability to approve multi-shipments at once*

Description of Change: Add ability for planners of ASN 2.0 portal to be able to approve multi-shipments at once from the shipment list.
