1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.36.0 includes some changes to main report for additional filter and output, some change on ASN 2.0 portal for the visibility of shippers to view all shipments that they created even when the shipper info has been changed by operator in CT2. Add additional feature to ASN shipment for specific PO Issued by to have default consignee. Add ability to set customs broker info value and some change to how output is displayed on accounting report. Replace URL from ct.jaguarfreight.com with mycyberchain.com as well as new logos for Elizabeth Arden and Cyberchain logo for log on page for client application.

3. Projects

3.1 ASN 2.0

- Mantis IDs: 0004609: [ASN 20] Make the "shipper company" that created the ASN a ASN property

 Description of Change: Provide visibility of ASN record for Shipper Users linked to the Shipper Company that created the ASN in case a shipper gets corrected or modified in CT2.
- **Mantis IDs:** 0004614: [ASN 20] (changes) Intl ASN

Description of Change: Change "ship to location" to be used as "delivery location" on import tab, provide mapping for consignee to specific PO issued by. This info will default to consignee created for shipment for specific PO issued by as well as provide Customs broker to be linked to specific PO Issued by if this info is needed.

3.2 Accounting

• Mantis IDs: 0004620: [Main report] Remove extra lines in case of grouped CTs and invoices in outputs.

Description of Change: Remove extra lines in case of grouped CTs and invoices ("Sales Invoices with Paid Amounts") in outputs.

3.3 Report

• Mantis IDs: 0004484: ASN statistic Report (ANA/TDS): Air/Ocean logics

Description of Change: Change logic for ASN statistic report and ANA report. For MOTs Air and Ocean, user can use ASN/ANA report: If Actual Delivery date is empty AND both Estimated AND Actual Departure date are empty AND Steamshipline/Airline is empty, then the shipment result will appear on ASN/ANA report. For MOT Truck, user can use ASN Statistic report: If Pickup Trucker is set AND Actual Pickup Date is set, then the shipment status will appear as "Picked Up." If Pickup Trucker is set AND Actual Pickup Date is empty, then the shipment status will appear as "Routed." If Pickup Trucker is empty AND Actual Pickup Date is empty, then the shipment status will appear as "Approved."

Description of Change: Re-design main report output to use the same concept as Portal and Flashlight output selection for flexible configuration.

- Mantis IDs: 0004592: [Main report] Add "Load#" as filter to the main report Description of Change: Add "Load#" as filter and output to the main report
