# CyberTrax2™ Release Notes

## 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

## 2. About This Release

CyberTrax2 Release 2.28.0 includes some bug fixes as well as an International Portal project a.k.a ASN 2.0 which is an additional functionality/feature from ASN 1.0 (Truck-Domestic only). This project provides client shippers and client planners with the ability to create and approve International shipments with mode of transportation, flexible layout, report capability, etc. Moreover, there are some slightly updated changes to ASN 1.0 functionality to provide a similar look and feel the same as ASN 2.0. Main functionalities for ASN 1.0 to remain the same. This release was for both shipper/planner portals and Internal Application.

**Description of Change:** Mainly focusing on International portal functionality with flexible user setting for shipper and planner portals

- ❖ Add/clone/view/remove an international shipment functionality for International shippers
- ❖ Provided ability for shippers to add container table for FCL shipment
- ❖ Provided ability for shippers to add truck size and type for FTL shipment
- ❖ Provided flexible shipment list with ability of shippers and planners to manage their own shipment list report view with ability to select fields and adjust size and order of columns
- ❖ Provided logging ability for all actions on each history field and comment with description, date time, and updated by info
- ❖ Provided ability for shippers and planners to add comment on Com Tab for communication to appear on Com tab on both client and internal application
- ❖ Provided ability for shippers to enter dims in inches or centimeters and cbm/cbft info for shipment
- ❖ Provided ability for shippers to select currency for shipment piece price as well as total GW unit of measurement and cbm/cbft
- ❖ Provided “Hazardous Note” field when shipment is set as Hazardous by shippers
- ❖ Provided ability for planners to approve status with mode of transportation or change mode of transportation that was transmitted by shippers
- ❖ Provided auto-approval configurable feature for international shipment
- ❖ Provided single approval feature for international shipment

- ❖ Provided double approval feature for international shipment
- ❖ Provided Air approval feature for Air shipment that required management to approve
- ❖ Implemented approval logic for partial and full commodity line items
- ❖ Provided arrow for shipments that have more than one commodity line item with the ability to expand /collapse to show info on shipment list
- ❖ Provided ability to create and transmit shipments to external 3<sup>rd</sup> party logistic provider with note recorded in Authorization history and Com tab
- ❖ Provided ability to configure shipment notification for shipment that is transmitted to 3<sup>rd</sup> party logistics provider via email notification with standard format of message
- ❖ Prevented planners to approve shipment without mode of transportation
- ❖ Provided immediate shipment search for filter selected
- ❖ Implemented cargo available and cargo due dates logic for international portal to be the same as ASN 1.0 but extended for all mode of transportations
- ❖ Provided Flag CT feature
- ❖ ASN form changes (layout)
- ❖ Download to Excel for CT records
- ❖ Printing functionality
- ❖ Provided mode, sub-mode, PO Issued by filters for international shippers and planners
- ❖ Provided option to show number of shipment list per page
- ❖ Cosmetic for CT viewer font size
- ❖ Changed Approval Status from dropdown to buttons for changing status with visibility approval feature
- ❖ Multi-select shipments approval functionality
- ❖ Changed Copy functionality on shipment list from “Right click info to copy” to “copy and Ctrl+C”
- ❖ Re-designed the layout of confirmation pop-up window for shipment creation and approval status confirmation and e-mail notification

**Description of Change:** Admin module has been designed and updated to support new functionality and flexibility for ASN 2.0 features. This is also support internal users to operate international shipments that were transmitted by International shipper and planner via functionality on dashboard report.

- ❖ Created and consolidated TMS and ASN admin and changed location on admin
- ❖ Re-designed TMS admin to support other E0. Client company – not hard coded to EA Dom Portal
- ❖ Changed user role admin to support new shipper and planner roles with existing shipper and planner functionality
- ❖ Created list of portals admin and portal profile for Transport Mode including Undefined shipment configuration with ability to add restriction rules and PO Issued by company
- ❖ Provided FTL and LTL flag for Truck mode to configure portal and display Truck info logic for FTL only on Portal profile admin
- ❖ Provided option on Admin for shipments transmitted by shippers to be auto- approval, single or double approval feature
- ❖ Provided ability to configure ASN transmission
- ❖ Introduced “View Only Planner” role

- ❖ Logic on Internal application for CT records that were created under ASN transmit to 3PL to not appeared on Internal application
- ❖ Created new version of Virtual group component to support all MOTs (upgrade- part 1&2) to create a group shipment
- ❖ Dashboard is available to configure for internal users “Approved But Not Action Shipment report” a.k.a “ANA Report”
- ❖ Re-designed SKU Planner mapping with auto populated description upload capability
- ❖ Re-designed Container size and type admin
- ❖ Merged Com and Equery tabs functionality to Com tab
- ❖ Added some new read- only fields defined for ASN 2.0 to be displayed on Gen Tab:
  - ✓ Cargo Available
  - ✓ Cargo Due
  - ✓ Planner
  - ✓ Shipper
  - ✓ PO Issued By
  - ✓ Approval Type

### 3.3 ASN 1.0 functionality

**Description of Change:** This release will affect the current ASN 1.0 as well for slightly upgraded designs to the look and feel. ASN 1.0 functionalities still remain the same.

- ❖ Shipment list managing column display is available for shippers and planners to manage their own shipment list with specific columns by right clicking on the header of column and manage or select columns to display as well as move column location and adjust column size.
- ❖ Shippers and planners can flag/unflag their shipments for their own watch list with right click functionality menu to flag, unflag, display only flag shipments, etc
- ❖ Approval status menu is now available as buttons instead of dropdown list option

## 4. Bugs Fixes and Changes

### 4.1 ASN 1.0 (Shipper/ Planner Portal)

**Description of Change:** Resolved a bug on Rejected On Date mapping value to be displayed. The fix now displays the value correctly.

Note that now Rejected On Date value is available for both ASN 1.0 and ASN 2.0.

**Description of Change:** Resolved a bug on the “Delivery to” Telephone number to map to the corrected field and display the correct value on PDF Trucking Pick Up Order. The old mapping pulled the fax number from the address book instead of the telephone number.

**Description of Change:** Resolved a bug on one of the fields to show proper value instead of HTML code on the report. This is for both dashboard and ad-hoc report for previous day delivery report.
