# CyberTrax2™ Release Notes

## 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

## 2. About This Release

CyberTrax2 Release 2.28.3 includes EDI Plus and Loading charges for Trendset project as well as 6 tasks for bug fixes and changes.

## 3. Projects

### 3.1 EDI to Trendset

---

- **Mantis IDs:** 0003824: *[EDI with Trendset] Billing to add Loading charges to submit to trendset*

**Description of Change:** Mainly focusing on transmitting loading charge for Truck-domestic shipment for Elizabeth Arden as a lump sum per truck load via EDI to Trendset. Loading charges invoices can be generated for shipment that is flagged as loading charges invoice in a master.

- **Mantis IDs:** 0003870: *[EDI with Trendset] SOW 12 EDI Plus for Elizabeth Arden*

**Description of Change:** Ability to transmit image/pdf invoices to Trendset through FTP folder. This allows Trendset to receive information in ANSI format as well as pdf file in order to compare detail information. This functionality is available for Truck-domestic invoices that transmit through EDI to Trendset for Fuel, Freight, and Loading charges.

## 4. Bugs Fixes and Changes

### 4.1 Dashboard Report

- **Mantis IDs:** 0003739: *Client App DB Report (Impending Arrival/Departure) - Total Containers Column*

**Description of Change:** Add “Total Container Count” as optional OUTPUT fields for both Impending Arrival & Impending Departure report. This “Total Container Count” is one of the selected default fields.

### 4.2 Accounting

- **Mantis IDs:** 0003881: *BUG: System generates two sales Invoices with one number # US37667*

**Description of Change:** Resolved a bug on duplicated Invoice number. Each invoice number must be unique throughout the system

- **Mantis IDs:** 0003804: (*\*Billing Required Report*) update criteria to provide including records with non-approved loss created over 120 days ago

**Description of Change:** Update criteria to include records with no actual date confirm as well as shipments created over 120 days ago with a loss without a “loss approved” flag. This is to prevent a black hole where an operator failed to enter any dates in the record.

- **Mantis IDs:** 0003524: *Past Due Report - Open CT hyperlinks in shipment editor & not shipment viewer*

**Description of Change:** Resolved a bug on CT hyperlinks in Past Due Report to open shipment editor instead of shipment viewer.

- **Mantis IDs:** 0003713: *Create new report that lists Client Company & Owner Office*

**Description of Change:** Generate XLS report with Client Company & Owner Office.

### 4.4 Ops Misc

- **Mantis IDs:** 0003700: (*Shipment Groups*) bug: *ocean CT added to group with different Ocean MOT doesn't update its own MOT to group MOT*

**Description of Change:** Resolved a bug on an ocean CT record that is added to an existing group with a different mode of transportation, mode of transportation for CT that was added on the group will be updated to the same mode of the group. For example, when a FCL(AW) shipment that is added to a LCL group then the shipment becomes LCL shipment with the same mode of transportation for all shipments in the group.

- **Mantis IDs:** 0003950: *All comments on "Com" tab should be visible for clients*

**Description of Change:** Resolved a bug on Com tab for all comments that are added on Com tab on Internal application will be visible to clients.
