# CyberTrax2<sup>™</sup> Release Notes

### 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

#### 2. About This Release

CyberTrax2 Release 2.42.9 includes some change requests to include impending and previous day report types to support poolpoint filtering and also add load distance mileages and kilometers as output fields to main report. Implement Hazardous Documentation Deadline to the TEvent tab. Ability to add Hazardous note on the master level with ability to set "Haz" option with a validation to at least one commodity item in a CT is hazardous when actual departure date is entered. Implement a log record for detail of master number for an e-mail notification that gets sent out to user who made a booking request.

#### 3. Projects

#### 3.1 Report

- Mantis IDs: 005086: [Main Report] For impending and previous report types add support for poolpoint filtering Description of Change: Implement new impending and previous day report types to support for pool point filtering.
- Mantis IDs: 0005094: IR> Main report add LD Miles as an output to the main report Description of Change: Add LD Distance Miles(Mi) and Kilometers(Ki) as output fields to the main report.

#### 3.2 Cargosmart

- Mantis IDs: 0005030: EDI to CargoSmart Add Hazardous Documentation Deadline to the TEvents tab Description of Change: Implement Hazardous Documentation Deadline field on the TEvent tab. This field is empty and allows the user to enter date information as this field does not auto-update yet because there is no mapping info from carrier/cargosmart.
- **Mantis IDs:** 0005031: EDI to CargoSmart Hazardous Information needs to be entered in the master **Description of Change**: Ability to enter a hazardous note at the master level when there is something in this master is hazardous (option: Yes). Remove validation per line item at the master level to only handle at CT level when at least 1 commodity line of a CT is hazardous. Validation is active when actual departure date is entered.
- Mantis IDs: 0005043: EDI to CargoSmart Log the Master# for e-mail notification to user who made a booking Description of Change: Add Master number on the detail on the log for e-mail notification to user who made a booking request.

• Mantis IDs: 0005042: IR > Show in a Master a list of recipients of comment sent via CT "Master Submit" Description of Change: Display a list of recipients of comment sent via CT "Master Submit". Note: This does not include a list of custom recipients emails.

• Mantis IDs: 0005078: EA > Add the GRP Number as a column and as an output in ASN Portal Description of Change: Add GRP Number (group number) as list of managing columns on shipment list and an output in ASN portal.
