1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.35.3 includes some change on ASN 2.0 for how to display data on CBM, CBFT, and weight data in separated columns for separate units. Display dim detail value from ASN portal to Internal Application on ContTab on Table B. Change on replacing a new flashlight logo onto the flashlight link on the header of client homepage as well as embedding the logo onto the flashlight component. Add "CT Total Sales" amount to the list of outputs on Main report. Bug fix on invoices that have charge code description longer than 256 characters to limit users to entering charge code description no longer than 250 characters.

3. Projects

3.1 ASN 2.0

• Mantis IDs: 0004606: [ASN 20 ph3] Output numbers and units of CBM and Weight in separate columns of ASN Download to Excel

Description of Change: Change to have separated columns for CBM, CBft, Gross Weight (Lb), Gross weight (Kg) and make all columns to be sortable on ASN download to excel.

• Mantis IDs: 0004507: [ASN 20] Display Dim value from ASN to Internal App> ContTab > Table B Description of Change: Add functionality to automatically populate Dims value from ASN 2.0 into Table B on Contents Tab. Implement immediate refresh of Table B to apply changes in commodity table in Internal Application when user adds or removes line(s). Text of validation message is changed to "The packaging count in the dimensions table does not match the packaging count for this shipment. This needs to be corrected before you can save this shipment." Remove "Meters" and "Feet" dims from Table B and leave only centimeters and inches unit and then convert old meters and feet dims value to centimeters and inches and migrate old data. Add validation message for CBM and HU to "Dims Table Error: Line level CBM cannot be Zero" and "The total package count for each line item cannot be Zero."

3.2 Flashlight

• Mantis IDs: 0004608: Flashlight: Replace text of "Flashlight" link with new logo FLASHlight" Description of Change: Replace the "Flashlight" link on the header to a flashlight logo button as well as embed a flashlight logo on the flashlight module.



• Mantis IDs: 0004610: [Main report] Add "CT Total Sales" amount to the list of outputs Description of Change: Add "Total Sales Amount" as output of Main report to show CT distribution amount per CT by using a value of "CT individual" distribution from P/L tab. Name the column of this value as "CT Total Sales". "Bill To" filter should affect result of the report in this output field.

4.1 Accounting

• Mantis IDs: 0004616: (Acc: SI&II) Bug: If Charge Code Description is longer than 256 chars then System doesn't save this line into Database

Description of Change: Change to limit Charge Code Description field to be no longer than 250 characters and fix bug to restore charge code description that is longer than 256 characters directly from the database to fix all broken invoices to solve this issue.
