#### 1. Introduction

#### 2. About This Release

CyberTrax2 Release 2.34.13 includes some changes to allow operators to change mode of transportation for shipments that were created from ASN portal. This functionality is being controlled per portal. Bug fix for e-mail notification for Hold and Reject shipment in international portal. Bug fix for undefined shipment to not be available on CT2 until it gets approved by the planners.

#### 3. Projects

#### 3.1 Operation

• Mantis IDs: 0004508: Allow OPS to edit MOT for ASN approved shipments to all internal users. Ctrl per portal Description of Change: Enable feature to control shipments that were created from the ASN Portal to allow operators to edit mode of transportation in CT2. This feature can be enabled per portal.

#### 3.2 Accounting

• Mantis IDs: 0004523: Error when trying to upload D2L Payment information Description of Change: Allow system to support D2L payment files to upload to CT2 that are larger than 64KB.
