1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.34.9 includes some new features to view the log of uploaded payment info and ability to download the uploaded files, some changes to allow operators to add commodity lines for ASN approved shipments in internal application. Adding level 2 on dashboard main report and re-label some output fields. Adding some new features to control dims validation per PO issued by and enabling the "Expedite" feature on ASN 2.0 portal as well as some bug fixes on accounting estimate P/L and ASN 2.0 portal.

3. Projects

3.1 Operation

• Mantis IDs: 0004481: (Ops) change: Remove restriction to add commodity lines for ASN records in internal app. Description of Change: Remove some restriction to allow operator to add more commodity lines to ASN records in internal application

3.2 Reports

• Mantis IDs: 0004482: Dashboard - Main report Level2 Description of Change: Enable level 2 main report dashboard result.

• Mantis IDs: 0004503: Re-label for output fields on main report Description of Change: Re-label for output fields on main report for containers description to container description to container size/type and containers to container number.

3.3 Accounting

• Mantis IDs: 0004477: Show a list of uploaded payment files (same design as for SKU uploaded files). Description of Change: Ability to view the log of uploaded payment files with the successful and fail results and ability to download the uploaded files.



• Mantis IDs: 0004491: [ASN 20] Dims validation per PO Issued by Description of Change: Add dim validation feature to enable per PO Issued by per portal.

• Mantis IDs: 0004499: Enable "Expedite feature" for ASN 2 portal Description of Change: Enable the existing "Expedite feature" on ASN 1 to ASN 2 portal.

• Mantis IDs: 0004505: Additional enabling "Expedite feature" for ASN 2 portal

Description of Change: Add Expedite button on ASN view shipment page the same as on the shipment page so that planner can expedite the shipment from the view shipment window. Create a comment text box for an expeditor to leave a comment. Allow expeditor to edit "Cargo Due Date" with the default value from the original cargo due date that planner set and allow an expeditor to change it. All action for expedited shipment, comment, original cargo due and revised cargo due date will be displayed on the comTab and the history log as well as on the email notification for an expedited shipment.

• Mantis IDs: 0004490: Change logic for the comment log on comTab for Air approval

Description of Change: Change logic for the comment log on comTab for shipment that requires air approval process.

4. Bugs Fixes and Changes

4.1 Accounting

• Mantis IDs: 0004486: System displays USD Amount = 0 on EPL tab for charges issued in other Currency from the non-current user's Office

Description of Change: For each estimate charge code rate, allow systems to save currency exchange rate based on issuing office for each charge code for future use in calculation of total USD amount on Est tab and all USD amounts on Est P/L tab per charge code line.

4.2 ASN 2.0

• Mantis IDs: 0004473: [ASN 20]Bug: The ASN2 portals display the entire address of "Ship to", it should only show "Company Name - City".

Description of Change: Fix the bug of displaying the entire ship to location address to only Company Name-city.
