## 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

## 2. About This Release

CyberTrax2 Release 2.34.6 includes ability to upload payment info from Data2Logistic to have payment info available as an output on main report in order to compare paid amount against invoices that were generated from CyberTrax. Change Daily report to not to include ASN approved shipment. Disable invoice info from the output list of the report on client application. Provide ability for JFS operator to edit hazardous info on GenTab as well as on commodity line item. Update dispatch email notification for EA International portal and some bug fixes on operation and ASN 2.0.

## 3. Projects

### 3.1 Accounting

- **Mantis IDs:** 0004470: *Upload Payment feature*

**Description of Change:** Add ability to upload payment info that is received from Data2Logistic to CyberTrax in order to store the payment info that has been paid in order to compare payment info against the invoices in CyberTrax.

### 3.2 Report

- **Mantis IDs:** 0004471: *Add "Uploaded payment info" to Main report output.*

**Description of Change:** Add payment info fields to list of output of Main report.

- **Mantis IDs:** 0004475: *(\*Main Report) Changes: Disable invoice output from Client app. Show container type counters, once per shipment*

**Description of Change:** Disable invoice output fields from Client application report and show number of container type one time per shipment.

- **Mantis IDs:** 0004479: *Daily Report: Block ASN Approved shipments*

**Description of Change:** Change Daily report not to include ASN approved shipment.

### 4.1 Operation

- **Mantis IDs:** 0004103: *(Ops) bug: "Hazardous" isn't set on gen tab but is set for commodity*  
**Description of Change:** Fix the bug on “Hazardous” field to be set on gen tab if at least one of hazardous field on commodity line items is set.

- **Mantis IDs:** 0004478: *[ASN 20] Bug: saving of ASN record with empty Unit Type dropdown value generates exception*  
**Description of Change:** Fix the bug on exception error showing when saving ASN record with empty unit type value
- **Mantis IDs:** 0004472: *[ASN 20] Bug: Wrong total value, when piece price is 0.01 and big Qty, CT#475045*  
**Description of Change:** Fix the bug on zero calculation for the total value and prevent user from proceeding to create a shipment if total value is equal “0.”
