1. Introduction

2. About This Release

CyberTrax2 Release 2.42.6 includes some request for changes from carrier on EDI to Cargosmart message.

3. Projects

3.1 Cargosmart

- Mantis IDs:** 0005006: *EDI to CargoSmart - Steamshipline contract numbers in EDI 300*
Description of Change: Change the default value to a contract number that is associated with the user's office (eg, HK contract number for HK user) and display the contract number to be used for the current booking request as well as offer an option for Jaguar user to select another contract for a specific request. Provide flexibility for user selecting steamshipline contract number in Master for sending it in Booking Request (EDI 300, segment N9, element 02 = N902) for a user generating the request.
- Mantis IDs:** 0005010: *EDI to CargoSmart - Send only Master commodity description in Booking Requests*
Description of Change: Send only a master commodity description in a booking request instead of a collection of shipments' commodity descriptions.
- Mantis IDs:** 0005019: *EDI to CargoSmart - Add Cargosmart dates to the TEvents tab*
Description of Change: Add all comments received back from Cargosmart to be listed in COM tab and any dates received back from Cargosmart to be added to TEvent tab. All comments from the master to be added to COM tab for all CTs that are a part of the master. The document due date is to be mapped to 304 submission deadline <date>. The cutoff date/time is to be mapped to cargos to port delivery deadline <date>.
