## **CyberTrax2<sup>™</sup> Release Notes**

#### 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

#### 2. About This Release

CyberTrax2 Release 2.40.4 includes some mapping of status updates from Cargosmart to populate in CT2 as well as sending suggested weight value upon transmitting a booking request. Provide more mapping for actual and billed weight and package type in EDI 110 to data2logistic for air shipment invoice. Create a script to clean the old load data that was migrated for lanes. As well as fix a bug that was preventing the generation of trucking EDI invoices in cases where they were not created from the trucking billing manifest.

### 3. Projects

#### 3.1 Cargosmart

  - **Description of Change:** Add mapping info received from cargosmart below:
    - EXPECTED SAILING DATE (DTM\*139\*<Date> under R4\*L) uploaded into ETD of Master Port of Loading.
    - EXPECTED ARRIVAL AT PORT OF DISCHARGE (DTM\*139\*<Date> under R4\*D) uploaded into ETS of Master Port of Discharge.
    - Shipping Instruction/BL Master (the Document Due Date as declared in DTM\*649\*<Date> under R4\*L) is shown as text line in "[Master] Bill Of Lading Comment".
      - Example: 304 submission deadline: <Date>
    - o CUTOFF DATE/TIME (ETA at Place of Receipt as declared in DTM\*139\*<Date> under R4\*R) is shown as text line in "[Master] Bill Of Lading Comment".
      - Example: Cargo to port delivery deadline: <Date>
- Mantis IDs: 0004909: EDI to CargoSmart Sending the weight in EDI 300

**Description of Change:** Add send suggested weight default value with validation below:

IF Master has no CTs attached to it, send suggested weight default

IF there is CT(s) attached to a master, send sum of CT(s) weights attached to the master

Except if CT(s) weight = "0" or empty then send suggested weight default.

This applies to all steamshiplines that are integrating with cargosmart, except Evergreen as Evergreen has its own format. Suggested weight" is managed for each type of container in "Container Sizes" tab of Transportation Admin.

#### 3.2 Operation

Mantis IDs: 0004907: [EDI to TMS] A script for 2nd phase of migration old Loads to Lane
Description of Change: Create a script to reset Total Charges to "0" for shipments related to the Loads in CT2 but not presented in the table of TMS "Allocated Report." And create a script to fill the CTs that were presented in the table of TMS "Allocated Report" with distributed charges per provided weights.

#### 4.1 Accounting
