CyberTrax2[™] Release Notes

1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.42.8 includes some additional filters and output to main report. Add more functionality to save or make a copy of incoming and outgoing files from and to Cargosmart to archived folder. Apply V1 segment in booking request to all EDI 300 messages for all carriers. Ability to transmit a booking request within a saved master shipment information as well as ability for master information to auto-save. Update booking party mapping for a specific office per OOCL's request. Create a log to record info when system receives a 301 EDI message from Cargosmart as well as log a record for an e-mail notification that is sent out to a user who makes a booking request. Add ability to save comment to the master when user clicks "Master Submit" button and add some new type of pallets validation: Standard pallet, mini pallet, and over-packed pallet type. As well as a bug fix on saving filter setting value for scheduled report for "No cancel" and "No transmit to 3PL" filter settings on main report.

3.1 Report

• Mantis IDs: 0005028: [Main report] Add "departure" and "arrival" filters to the "previous" section, "ocean coloader", "air co-loader" to the output

Description of Change: Add "Departure" and "Arrival" filters to condition "Previous" section as well as add "Ocean co-loader" and "Air co-loader" to the list of output.

Description of Change: Create a log to record when system receives a 301 message and system sends an email notification to a user (e-mail address) who made a booking request.
