CyberTrax2™ Release Notes

1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

2. About This Release

CyberTrax2 Release 2.39.0 includes pool point re-design project for CT2 and TMS to support pool point functionality for shipments. Integration with Cargosmart to receive status updates from steamship lines. Change a pdf invoice form to include place of receipt, incoterm and origin terminal information. Add ability to upload and download detailed contents section. Create a new KPI to measure the carrier performance between the estimated date vs actual date of pick up, departure, arrival and delivery. Remove “CT container size and type” fields from the output list but add “Master container size and type” to the output list. Ensure “pending approval” report to include all shipments on ASN New tab. Also include bug fixes from ASN, Flashlight and operation modules.

3. Projects

3.1 Pool point /TMS

- **Mantis IDs:** 0004168: *Pool Point re-design project*

Description of Change: Create ability for CT2 to support pool point shipments. Implement all ASN, CT2 Client, CT2 Internal visibility to all loads using logic: IF the first load tender shows a delivery location that is different from the CT2/ASN "ship to Location" THEN “delivery to location” is a pool point AND the second load tender shows a delivery location that is different from the CT2/ASN “ship from location” and “pick up location” is a pool point THEN add the second load tender information to CT2 and add all costs/ miles / carrier info to CT2 to flashlight, reporting, etc. Show all transportation information on “Lane” tab. Record all actions into system log.

- **Mantis IDs:** 0004838: *Pool Point / ASN relabeling*

Description of Change: Re-label information in pick up instruction to show a carrier name and re-label load numbers in ASN view window to show a carrier name for all loads. Examples:

3.2 EDI with Cargosmart

- **Mantis IDs:** 0004743: *EDI to CargoSmart*

Description of Change: Implement EDI to Cargosmart to send booking request and shipment instruction to receive status messages to update CT2. Create ability to add contract number per office for each steamship line in admin.

3.3 Accounting

- **Mantis IDs:** 0004802: *(Sales Invoice) Change Invoice Form to add "Place of Receipt" and "Incoterms" information*
Description of Change: Add "Place of receipt," "Incoterms," and "Origin Terminal" information on a pdf invoice form.

3.4 ASN

- **Mantis IDs:** 0004575: *[ASN 2.0] Create a way for suppliers to upload the "contents section" to ASN.*
Description of Change: Implement an ability to upload commodity for ASN and CT2 (internal and external) from spreadsheet. Create a template of spreadsheet for uploading. Each uploading will replace the previous upload data. For internal user, there is no restriction for the upload. For external or ASN user, only the shipper who did the first upload is allowed to re-upload. The spreadsheet template will include all fields including internal information. For ASN users only mandatory fields will be visible but for all fields will be visible on CT2. For specific PO issued by that contains SKU mapping description, after upload the spreadsheet the description will be automatically populated from SKU map.
- **Mantis IDs:** 0004811: *[ASN 2.0] "Detailed Contents Download" feature*
Description of Change: Create a "Detailed Contents Download" button on ASN portal and CT2 for ability to download detailed content including dimension information if there is any on a spreadsheet.

3.5 Flashlight

- **Mantis IDs:** 0004801: *Carrier Performance KPI: Actual vs Estimated Dates*
Description of Change: Create a new KPI to measure carrier performance to compare estimated date and the actual date of pick up, departure, arrival, and delivery.

3.6 Report

- **Mantis IDs:** 0004805: *[Main report] "Pending approval" should show ASNs that are listed on the NEW Tab only*
Description of Change: Implement pending approval report to show all ASN shipments that are listed on the New Tab.
- **Mantis IDs:** 0004814: *(Ops:Reps) Main report: Remove "CT Containers" field*
Description of Change: Remove "CT Containers" field from the output list fields.
- **Mantis IDs:** 0004825: *(Ops:Reps) Main report: Add (Clone) "Master Container Size/Type" Output field*
Description of Change: Create output fields for "Master Container Size/Type" that is basically cloned from "CT Container Size/Type" output field from CT category to group/load/master category.

4. Bugs Fixes and Changes (none)

4.1 ASN

- **Mantis IDs:** 0004827: *[ASN 2.0] Sometimes ASNs become delivered before approved.*
Description of Change: Some ASNs become delivered before approved. This was a case of shipment that was put on hold with approved date but got routed by TMS before it was actually approved and it's possible that TMS delivered the ASN before ASN becomes approved. Then the ASN is not visible in a portal. Need to handle such kind of ASNs to make them approved on the date of routing shipment (approved ASN even if it's already delivered).

4.2 Flashlight

- **Mantis IDs:** 0004834: *Scorecard > fix KPI values for Scorecards*
Description of Change: Add common option for scorecard builder:
 - * Internal application – Cost Type: Purchase/Sales.
 - * Both applications: Include/Exclude VAT/Duties optionFor Cost based KPIs: Account all Sale invoices for Client and Internal application (Sales cost type mode), make Internal Cost based KPIs (Sales mode) comply with corresponding KPI in Client application.

4.3 Operation

- **Mantis IDs:** 0004828: *(Ops) If create Invoice in Trucking CT and click "Create CT" without saving the CT, system generates exception*
Description of Change: Fix the bug when creating an invoice in Trucking CT and click "Create CT" without saving the CT, system generates exception after confirmation to save the CT. Now it is no longer generating unknown exception error.
