# CyberTrax2™ Release Notes

## 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

## 2. About This Release

CyberTrax2 Release 2.30.4 includes some new ASN functionalities to the portals, some new additional filter for Main report, some additional option for Past Due report to map data against cargo due date as well as bug fixes on Internal and Client application.

## 3. Projects

### 3.1 Ops: Report

- **Mantis IDs:** 0004194: Add "In Transit conditions" to Main Report

**Description of Change:** Add additional option as a checkbox on condition filters tab with a label "Show In Transit records only" to apply "In Transit hardcoded conditions" to results of "Main Report."

- **Mantis IDs:** 0004220: New Report Request - Past Due against "Due Date"

**Description of Change:** Create an option to the "Past Due" report for "Cargo Due" type with cargo due date as a filter. This report is mapped data against "Cargo due date" instead of "Estimated delivery date". "Created on date", "Authorized date", and "Cargo due date" are additional output fields that added to both "Previous Day" and "Past Due" reports.

### 3.2 ASN phase III

- **Mantis IDs:** 0004160: [ASN 20 ph3] ASN flag: Notification Email & SMS. Client Watch list

**Description of Change:** Add flagged ASN shipment(s) to client Watch List on homepage automatically. This feature also can be set on My Profile on Watch List Shipments Status Notifications section in order to turn on/off e-mail and/or SMS notifications. There are some changes on how to display the status bar with mouse over description with an appropriated date on Authorization column on watch list. For "Rejected" shipment, it is automatically removed from "Watch List" one month after status was rejected. For "Delivered" shipment, it should be appeared in "Watch List" for 1 week and then removed to "Archived" tab. For ASN record that is unflagged, it will be automatically removed from "Watch List"

- **Mantis IDs:** 0004079: Expedited Shipment Approval Feature

**Description of Change:** The "Expedited Approval" functionality is an optional feature, available in the ASN portal. This provides significant opportunities to drive cost saving and increase productivity and efficiency by reducing exceptions, by identifying the root cause(s) for expedited shipments. The ability to approve Expedited Shipments is assigned on a user specific basis, as an additional user credential. As an additional option, a reason code can be mandated in order for an approval to be processed. This is for Truck-Domestic ASN portal only. Reason codes are to be managed in Admin module under "Transportation". E-mail notification will be sent out to shipper and planner when shipment is expedited.

- **Mantis IDs:** 0003925: [ASN 20 ph3] Support additional ASN 2.0 Fields/Columns (on download to xls and flexible shipments list)

**Description of Change:** Implement support additional ASN 2.0 fields/columns in shipment list on flexible shipment list display feature as well as output list on download to excel.

- **Mantis IDs:** 0004173: [ASN 20 ph3] 3PL output field

**Description of Change:** Add 3PL as an additional field to be available on the output list of download to excel as well as on flexible shipment list display.

- **Mantis IDs:** 0004006: [ASN 20] change: add validation for Cargo Due Date and Cargo Available Date

**Description of Change:** Implement validation for Cargo Due date to be after Cargo available date. System does only allow the CT's cargo due date to be equal or greater than the CT's cargo available date and CT's approved on. If Cargo due date does not correspond the condition, system should display warning message and not allow user to complete the performed action.

- **Mantis IDs:** 0004014: [ASN 20] change mapping for "Ship To Location" in Air/Ocean records

**Description of Change:** Implement some mapping changes for "Ship To Location" for Air and Ocean records. Consignee address should be listed on "Consignee" as well as on "Deliver Location" on *Import tab* instead of "Export Pick up Deliver to address." For "Export Delivery To (T5)" on *Gen Tab* remains blank in this case.

## 4. Bugs Fixes and Changes

### 4.1 ASN 2.0

- **Mantis IDs:** 0004105: [ASN 20] Bug: Auto approved CTs were not sent to TMS

**Description of Change:** Fixing bug on ASN2.0 for "auto approval" functionality to send shipment record(s) to TMS similar to regular manual approval process to send record(s) to TMS.

### 4.2 Client Application

- **Mantis IDs:** 0004019: Bug: System throws an exception when trying to generate Manifest Report.

**Description of Change:** Fixing bug for system throws an exception when trying to generate Manifest Report, on container tab in CT's detail view.

- **Mantis IDs:** 0004146: bug: Error when Client user tries to download document/files

**Description of Change:** Fixing bug on error when client user tried to download documents/files. This issue appeared in Internet Explorer 8

- **Mantis IDs:** 0004219: *"Client Company with Owner Office" report does not work*

**Description of Change:** Fixing bug on java NullPointerException error when user tried to generate "Client Company with Owner Office" report.
