## CyberTrax2<sup>™</sup> Release Notes

#### 1. Introduction

This document notes the major new features and changes in this release of CyberTrax2. It also documents known problems and workarounds.

#### 2. About This Release

CyberTrax2 Release 2.38.4 includes some change of how to display fiscal/calendar year for KPIs as well as implement additional "LeadTime" KPI to include "Approved to Load Tender," "Load Tender to Pick up Date," " Load Tender to Delivery," and "Load Tender to Cargo Due." Create "Fiscal/Calendar Year" as a client company option for flashlight. Also include bug fixes to operation on document center tab to view/download file/document from client application as well as bug fixes on main report to exclude "Approved by Super Planner" and other KPI output fields from the output fields as they were added by mistake and not implemented in the proper way.

#### 3. Projects

#### 3.1 Flashlight

• Mantis IDs: 0004654: "Fiscal / Calendar Year" option for KPI

**Description of Change:** Create a "Fiscal/Calendar Year" for Client Company option for Flashlight. It is for using in Performance report and for KPI's timeframe of quarter/year. Every company can set its own date for the beginning of its fiscal year. System calculates/shows weeks from Monday to Sunday.

• Mantis IDs: 0004783: LeadTime: "Load Tender" Date

**Description of Change:** Implement additional LeadTime KPI to include "Approved to Load Tender," "Load Tender to Pick up Date," " Load Tender to Delivery," and "Load Tender to Cargo Due."

#### 4. Bugs Fixes and Changes (none)

#### 4.1 Operation

• Mantis IDs: 0004788: (Ops) bug: Error in CT Files tab when setting a "file" to "show Client.

**Description of Change:** Bug fixes on error in CT files tab when setting a "file" to "show to client." It generated error on clicking to view/download a file on document center tab from client application.



#### 4.2 Report

• Mantis IDs: 0004786: [Main report] bug: "Approved by Super Planner" field in the Main Report output doesn't work. Description of Change: Exclude "Approved by Super Planner", "Port Of Origin," "Port of Destination," "Load Tender Date," "Carrier," "Approved By Super Planner Name," and "Commodity Item Hazardous" fields in the main report output as it was added by mistake and not implemented in a proper way. It will be added back in the future when we get to implement all additional outputs.
